1. Call to order the Budget/Levy meeting: The meeting was called to order by Chair Mantay at 6:19 pm.

2. 2027 Proposed Budget/Levy

- Following a review of past levies, the Board engaged in discussions regarding anticipated expenditures for 2027. Supervisor Anderson motioned to approve the proposed levy amounts for General: \$35,000; Roads & Bridges: \$8,500; Fire EMS: \$26,000; Buildings: \$10,000, and Chair Mantay seconded it. This motion was carried unanimously.
- The total proposed levy for 2027 is \$79,500.
- At the annual meeting, the board will submit the proposed recommendations for a vote by the attending residents.

Total Votes: 26


